- -The establishment of a Citizen's Advisory Panel for the SRST will be accomplished this year. Don Kain and Mike Liberati have the lead on this item, and progress will be reported in future SRST meetings.

Phase II Eco-Study Conceptual Plan – *Todd Morrison, URS*

- -Plan is guided by NRDC
- -Slide 2 grayed sections of spreadsheet are areas where more characterization is wanted.

- -Corbicula filter feed from water column and feed off of substrate. Corbicula will be used to differentiate between water column and substrate loads. Caged/suspended Corbicula will be filter feeding whereas the seeded Corbicula will be feeding off the substrate.
- -Biological sampling will be occurring over the same period as physical/chemical sampling.
- -Fish sampling will be addressing variability by sampling recaptured fish and by possibly analyzing frozen archived samples.
- -Mayflies and caddis flies may be looked at to address low level food web organisms.

Bank Stabilization Pilot Project – Nancy Grosso, DuPont
